PRESIDENT'S REPORT – Tim Fry

On behalf of the Board of Lacrosse Victoria I am pleased to be able to make this, my second report to our members and the broader lacrosse community. This report covers the 2013 Lacrosse year and provides an overview of activities and developments at Board level.

The past year has been a momentous step forward for our sport. We implemented many of our stated action areas from the 2013-2017 Strategic Plan and in doing so we have hopefully set lacrosse on a path of future growth. Whilst our registered playing numbers have not grown dramatically over the past 5 years, the change and initiatives being implemented now have strengthened our prospects for growth in the future.

2013 has been a year of change, which has meant stepping out of our comfort zone and into uncertainty; which by nature does not come easy. This has meant LV has been more consultative and very purposely spent a tremendous amount of time and effort engaging with members through meetings, forums, and surveys to assist LV in the decision making process. The Board takes very seriously the need to collaborate and consult with its members, so much so that in 2014 we will finalise our consultation/collaboration policy.

In 2013 the Board implemented a major action area of the 2013-2017 Strategic Plan by appointing Mr Rod Kimmitt to the newly created General Manager role. The creation of the role was in recognition that if we as a sport are to achieve many of the strategies stated within the Plan, resourcing and a new way of doing business is critical.

Mr Kimmitt has brought a wealth of sports administration experience to the role having previously worked at Cricket Australia, which has been essential in considering how we can do things not only differently, but better in our pursuit to grow the game.

I can sadly say Membership numbers still keep me awake at night. In 2013 we experienced a decline in our junior boys, but excitingly, growth in junior girls. The Board, through the hard work of the Junior Development Committee, is acutely aware of the overall decline in playing numbers; which has motivated the development of the QuickStixs Program, alignment of junior age grouping for 2014 and the introduction of junior zone councils. Ultimately, membership data is the important success measure, (particularly in the junior ranks) which the Board monitors very closely. It will be an absolute imperative for 2014 to develop ways to better record and measure participation and membership data.

Another area that will require considerable attention in 2014 is how we better measure the impact of new and existing initiatives. It is vitally important that we develop a culture of evaluation to understand what works, what doesn't work and what improvements are required. This thinking also applies to the Boardroom to improve how we govern the sport.

One of the most significant achievements for 2013 was the Men's and Women's State League and Under 18 Grand Finals played at the wonderful new facilities at Lakeside Stadium. This is the first time lacrosse has been back to Lakeside since 1991. The decision to host the Grand Finals at Lakeside was a strategic initiative of the Board to increase the profile of lacrosse through better showcasing our premier product in an attempt to attract the non-lacrosse spectator, improve sponsorship opportunities and improve the professional appearance of the game. If we are to truly

promote our game we must continue to take steps to improve the presentation of our premier leagues.

The Grand Final was also an historic day with Footscray Lacrosse Club winning the Men's State League Grand Final for the first time and also being the first amalgamated Men's and Women's lacrosse club to win both the Men's and Women's State-League Grand Finals. Importantly, much of Footscray's success on the field in 2013 can be attributed to their hard work in recruiting junior players over the past decade. If you cast your mind back, it was not that long ago that Footscray's top team was in Division 1. A clear message that the success of a club should not be solely measured by their on-field performance, rather the strength of their junior numbers and recruitment initiatives.

It was very encouraging in 2013 to see some new faces amongst the Club Committees and LV subcommittees. Developing the future generation of leaders for our sport is critical to its ongoing growth. Interestingly we place a great deal of emphasis (and rightly so) on coaching and official development/accreditation, however as a sport we do not have any set pathways to nurture young people into future leadership roles. How we do this will be a key focus area for the Board in 2014.

From an administration perspective, after years in cramped office space and dealing with ageing IT equipment the Board is very pleased to see Lacrosse Victoria staff in a new office space within Sports House and new IT equipment.

Mr Paul Clough (Manager) made the decision to retire at end of 2013. Paul has been an amazing contributor to Lacrosse Victoria and his presence will be missed, we wish him all the best in retirement.

We are indebted to our previous and current board and sub-committee members whose enthusiasm and hard work are invaluable. I would like to thank Mr Max Lee, General Director, Mr Cliff Jennings, General Director (High Performance) and Carolyn Bolton, General Director for their service to the Lacrosse Victoria Board. Their leadership and strategic thinking will be greatly missed.

In particular, I thank Mr Rod Kimmitt and all of the Lacrosse Victoria Office staff for their leadership and support. None of the accomplishments of the past year would have been possible without their efforts.

I would like to take this opportunity to thank the Victorian State Government (particularly, Sport and Recreation Victoria) Local Councils, VicHealth, and VicSport for their continued support and leadership. We look forward to working with you in 2014.

Lastly, I would like to thank all Club Presidents and committee members for their commitment to the game of Lacrosse; we are blessed to have such talented and passionate people in our sport.

For our sport to grow, we must continue to make future based decisions; that being every decision we make is made in the context of how it will influence the growth of the sport in 5 -10 years' time. On behalf the Board of Lacrosse Victoria we look forward to further growing the game 2014.

General Managers Report- Rod Kimmitt

It is with a great deal of optimism that I make this first contribution to a Lacrosse Victoria (LV) Annual Report. My first six months in the role have exposed me to the many challenges facing our great game as it battles to remain vibrant, relevant and sustainable in an increasingly competitive sporting environment. However, equally and perhaps more importantly, they have introduced me to the many dedicated volunteers, players, parents, supporters, officials and coaches that make up the lacrosse community. It is this community that will ultimately determine the course of Lacrosse and I look forward to working together to ensure a bright future for the game.

Before reflecting on the year past may I take this opportunity to thank Paul Clough for his diligent work for lacrosse, and on a personal note for assisting me in transitioning into the newly created General Manager's role. Paul should be acknowledged for his efforts and I wish him well in his well-earned retirement.

2013 has seen significant change in Victorian lacrosse as we begin to implement the Lacrosse Victoria Strategic Plan 2013-17 and lay the foundation for success. The key pillars to the plan, as laid out below, will provide the roadmap that allows us to reverse recent trends, drive sustainable growth and embrace opportunity.

- 1. Promote and enhance the profile of Lacrosse
- 2. Provide innovative and accessible pathways for participation for all Victorians, in the sport of Lacrosse
- **3.** Structure the financial and social investment, to secure the sustainable future of Victorian Lacrosse
- 4. Deliver and promote 'good governance' to our community through transparent leadership and processes

However simply putting these words on paper does not guarantee success. It is the challenge of all in the Lacrosse community, particularly its leaders, to be prepared to make brave, and sometimes uncomfortable decisions if we are to truly embrace the possibilities ahead.

Successes

As mentioned, 2013 has seen significant change and a number of key initiatives need to be highlighted.

The hosting of the 2013 State League Men's and Women's and U/18 Boys and Girls Grand Finals at Lakeside Stadium presented Lacrosse with an opportunity to showcase the sport. The weather gods played their part and players were given the chance to shine in front of an enthusiastic crowd of between 1300 and 1400. The players did not let the supporters down with four games of the highest quality delivered, culminating in the Footscray Lacrosse Club creating history winning both Men's and Women's State League titles on the same day.

In the area of development staff and volunteers continue to work diligently. LV's Teacher Workshop Training was delivered in 12 schools and Universities to over 600 teachers. This program will assist in raising the profile and credibility of Lacrosse in the school environment and ensure we have champions of the sport in place as we drive participation in the schoolyard.

The LV School Gala Days continue to grow in popularity and this year's 4 competitions saw 24 schools and 636 children take their first steps on their Lacrosse journey. Bill Gray and his team of volunteers have made significant inroads in introducing Lacrosse into Girls Sport Victoria affiliated schools with 79 clinics delivered to 933 students. We should see the results of this activity over the next 12 months.

Funding through Sport and Recreation Victoria's Victorian's More Active program allowed LV to support a number of club's develop the Southern Indoor Lacrosse League. Congratulations to those involved on a successful launch. This initiative, along with established programs like the MILL, provides additional pathways to introduce new players to Lacrosse and deepen the engagement of many others, and will be critical to broadening the reach of Lacrosse.

For the first time we have conducted a membership survey of LV Members. This survey was distributed to all LV players, coaches, officials, club committee members and junior parents. This survey will not only give us an insight into our members perception of our service delivery, but allow us to monitor our performance over time, thus ensuring we create an environment that responds to the needs of our members.

Our High Performance teams have also enjoyed success in the 2013 season highlighted by our National Championship winning U/18 Girls and Senior Women's teams being nominated for the prestigious VicSport Team of the Year awards. Unfortunately in fields of the highest quality they were unsuccessful but that does not diminish the achievements of these teams. Our Men's Indoor teams and U/18 Boys also enjoyed success at a National Level. Congratulations also to those involved in the 2013 Australian Women's World Cup campaign which saw them return with a Bronze Medal and the respect of the Lacrosse world.

Challenges

Lacrosse in Victoria and indeed across Australia faces a number of challenges in an ever competitive sporting landscape which must be addressed. We must find a way to raise the profile of the game beyond the inner circle and let the rest of Australia know what we know, that Lacrosse is a dynamic sport that provides unlimited opportunities for all participants. With limited resources we need to work together to find new, innovative ways to *'Let sport's best kept secret out'*.

We must build our participation base. Despite the determined efforts of our existing clubs the indisputable fact is our playing population has stagnated and is concentrated in too small a geographic area. To grow we need to develop a Lacrosse footprint in Melbourne's growth corridors and Victorian Regional hubs if we are to create more than incremental growth. This will not only allow us to reduce barriers such as travel, time, and competition depth but address the increasing cost pressures placed on our current membership base.

Looking ahead

2014 will see the LV office focus on delivering the objectives of the LV Strategic Plan and addressing the many challenges identified earlier in this report. Work has already begun in many cases and we look forward to rolling out the new "QUICKSTIX" entry level program over the early part of the 2014 season.

LV has also been successful in creating a partnership with Sport and Recreation Victoria, The City of Greater Bendigo and the Bendigo Lacrosse Association to deliver a first for the sport in Victoria. The

2014 ALA U/18 National Lacrosse Championships will be held in Bendigo over the Easter Period and creates a unique opportunity to raise the profile of the game in Regional Victoria as well as strengthen our relationships with key stakeholder groups.

An increased focus will be placed on introducing the game to the schoolyard and through greater levels of co-ordination and collaboration build on the good work currently being undertaken by our club networks and the GSV group. Initial talks have already taken place with School Sport Victoria to develop a partnership which will ultimately allow us to expose Lacrosse to 80% of Victoria's over 2,400 schools.

Our competition structures will also be reviewed to ensure that they are structured to deliver the best possible experiences for our players, coaches, officials and volunteers and support our growth initiatives.

Work will also continue to develop the quality and quantity of our officials and coaches. This development of this group is critical to the experience of our participants and future growth and sustainability of the game.

Acknowledgements

I would like to take this opportunity to acknowledge the efforts and support of a number of people and organisations without whom our sport would struggle to exist.

LV is blessed to have a small but highly dedicated team in the office to keep the wheels turning. To Kristen Stone, Maureen Austin, Sandra Hecker and Paul Clough a huge note of thanks. The tireless work you do behind the scenes, much of it out of hours should not go unrecognized.



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2013

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Association Incorporations Act (Victoria) 1981. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money value or, except where specially stated, current valuation of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a. Income Tax

.....

No provision for income tax is necessary as the Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

b. Inventories

Inventories are measured at the lower of cost and net realisable value.

c. Plant and Equipment

Plant and equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all plant and equipment is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

d. Impairment of Assets

At the end of each reporting period, the association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indicator exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is recognised in the income and expenditure statement.

e. Employee Benefits

f. Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

g. Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other shortterm highly liquid investments with original maturities of three months or less.

h. Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

i., Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Last but not least, Tom Bell for his selflessness and willingness to be the Team Scorer.

A big thank you to our sponsors: UK Hotel, now know as Café 307, Vic Health, and Greater Bendigo City Council. Our sponsors who donated monies, or paid for ground hire or gave us grants to purchase uniforms and protective gear. Bunnings BBQ at Kangaroo Flat assisted with our BBQ fundraisers by providing the BBQ, gas and site. The financial gain from the BBQ event was a pleasant surprise.

Senior Section

A few players left the club last season due to interstate work or personal reasons. Some departing were very capable lacrosse players at that but we welcomed several new players. Mark Reader put his hand up to coach and has in my opinion the attributes of being a great coach, however due to external forces (building his house) he had limited opportunities to develop the team. This year was a very good year but the win/lose ratio did not reflect it. Most games were competitive except for three games when the scores ballooned out.

The club made the right decision to leave the Athletic Track at Flora Hill and make our training ground, the Maiden Gully Recreational Reserve, our playing venue as well.

We kicked off the year with a practise match against South Australia's Woodville Lacrosse Club. It was Bendigo's first even game against a South Australian team.

We hosted another State League First Round at Bendigo's Epsom Recreation Reserve. It was a successful event in the eyes of Greater Bendigo City Council and Lacrosse Victoria because of the exposure to the Bendigo community. However, financially it was not as successful as anticipated considering all the efforts from club members, family and friends to just almost break even. Again big thanks go to all the guys that helped before, during and after the event.

The committee and club people voted to accept Lacrosse Victoria's proposal to host the event for the next three years. With a dedicated team of four, the "Fantastic Four" are: Russell Crofts, Mark Reader, Brett Ruiz and Marty Boyle who have volunteered to organise it. I am sure it will be a bigger and better than last year.

Financially we have done quite well this year, even though the bank statement show that our savings only increased by \$100 or so. There were enough funds through grants etc that managed to cover the cost of hiring the Athletes track, as the invoice came in 2012/2013 financial year (\$1100) and should have been allocated to 2012 year.

The club has always tried to keep costs to members as low as it can afford. Through BBQs and other fundraising items the committee managed to reduce fees from last year., Furthermore, there was minimal transports cost incurred by members (\$2) compared to car pooling costs incurred in 2012.

The club was fortunate to obtain grants totalling approximately \$3,500, from VicHealth and another government department for uniforms and protective gear. We won't be able to apply for these types of grants again for another two years but there are other grants which I hope to apply for in the hope to purchase protective gear for future U14 junior teams.

Fundraising by Martin Boyle has been successful in raising \$300 for our next venture in team apparel, polo shirts or water proof jackets. The money raised by Martin helped reduce the costs of the hoodies. Other items obtained were club beanies and "Warhawks" socks, which were sold to club members at costs prices plus a dollar.

I have recently received good news and that was that the cricketers have given permission for us to build a padlocked shelfing system to store the entire club's equipment over summer and winter.

Junior Section

After its' third attempt Eaglehawk North Primary School won the Lacrosse Victoria Division 3 Primary School Competition in November 2012. Bendigo Senior Secondary College again entered a team in the Lacrosse Victoria Senior Secondary School Competition and performed very well. The club assists these schools as way to further the game of lacrosse and recruit potential players in the future.

The U12 junior competition commenced in Term 1 and continues in Term 4. In Term 1 we had 14-16 junior players and in Term 4 we have 26 juniors. Competition is on Thursday's nights from 4.30 to 6.00pm.

Children were recruited from schools that held clinics conducted by the club during Term 3. Schools that had clinics were Girton Grammar, St Therese's, St Killian's, California Gully, Maiden Gully, Quarry Hill, and White Hills Primary Schools. It is expected that these schools and 4 different schools will be approached to have clinics next year in Term 3.

The junior competition consists of four teams that are made up of children primarily from the above primary schools. The teams are called Sioux (Girton), Cheyenne (Maiden and California Gully),

Cherokee (St Therese's and Killian's) and Navajo (Quarry Hill and others). Results are printed in the junior sport section of the Bendigo Advertiser every Tuesday.

I hope we can establish a secondary school competition (U/14) late next year, but clinics will need to be held and protective gear bought to supply the children. It is hoped this will be a feeder to the senior men team. We will need to look for female ex-lacrosse players to assist with our girls as there is a mix of approximately 50% boys/girls in our junior ranks.

KNOX

For the first time in its history, Knox Lacrosse was unable to field one complete team, either senior or junior, in a Lacrosse Victoria competition. This was not the position during Term 1 of that year when both senior (Div 3) and junior (U14) had 10 and 8 players respectively on the books. However, when some of the anticipated junior players then failed to materialise, the Club decided that Knox should combine with MCC who also lacked U14 numbers. When 2 senior players did not confirm availability, the Club decided that other senior players were best advised to join other Clubs for season 2013 and these players disbursed to MCC, Malvern and Chadstone.

Inevitably, some of these senior players were able to play in higher grades with other Clubs and 2 have advised Knox that they will not return for season 2014. However, 2 past players of Knox have indicated that they wish to return to the game and the basic 10 players are again available on paper.

To field that senior team, the Club needs a more certain administration than it had available at the end of 2013. During 2013, our President advised that changing domestic circumstances made it impossible for him to continue to the end of the year let alone into 2014. The Association Reform Act, which forced the Club to adopt a new constitution in September 2013, requires a minimum of 5 members to form a not-for-profit Club; The Club has advised the Lacrosse Victoria Board of the urgent need for support from some senior lacrosse personnel (current or retired players) so that a Committee can be formed to carry the Club into 2014.

Ken Hickey has provided the Club with excellent service as President over the past 3 years. Because he worked close to Benedikt Reserve, he was able to support teams both as President and as senior team coach. We sincerely thank Ken for all his help over these past years and acknowledge that a change of residence makes it difficult for him to continue in any official capacity.

As for the junior team, the players had an enjoyable season playing with MCC but only a few games could be played at Knox during the season and this of course limited the profile of lacrosse in this area. John Cantone put much effort into U14 recruitment for the season and shared the coaching role with an MCC representative although this shared responsibility caused a few difficulties. However we thank John for ensuring a Knox presence during that season. One success for the Club was in the award for Most Valuable player in the team; Ashleigh Mulraney shared the award with an MCC boy and prior to the last match was even one vote in front. A most gratifying result! Our thanks also to Shirley Clarke for such strong support for the team in transport and in scoring for the matches.

Beyond the season, I have been busy throughout Term 4 to advertise lacrosse in the local area. Scott McKissack assisted me in running an Active After School program at Karoo Primary School in Rowville; a second Active After School program at Waverly Meadows Primary School resulted in at least one player joining the Wednesday afternoon games at Benedikt and a few other boys from the Pinewood area also arrived; the third AASC activity was at St Andrews College near the Knox Shopping Centre. Besides publicity, the AASC programs enabled funds to flow to the Club, adding to the excellent fundraising efforts of Jo Gannon and other parents. However, the recruits cover a number of age level areas and do not necessarily supplement the 2013 U14 numbers.

For publicity in secondary schools, we arranged with Wheelers Hill Secondary College to provide a couple of sessions of lacrosse for each Year 7 and Year 8 class. The weather was not kind to us (rather wet) but we received strong support from the teachers involved. I thank John Cantone and a Chadstone senor girl for assisting with this program.

To encourage Primary School competitions in this area, the Club organised a Year 6 competition in which over 200 students from 4 schools participated and the winners also competed in the Lacrosse Victoria Eastern Region final later that November held at Benedikt Reserve. Finishing the year, the Club organised a Year 7 lacrosse competition on the second last day of Term for Scoresby Secondary College to baptise the 2 kits of lacrosse sticks which that school had recently purchased. This last activity relied on the support of Club members John Cantone, Scott McKissack, Ashleigh Mulraney and Isabella Williams – many thanks!

Although player recruitment continues to be a difficulty, the greatest need of the Club at present is for senior administrators. When this Club was starting, I, as a member of the Victorian Lacrosse Association committee, was asked to take responsibility for liaison with two small Clubs. Doncaster

was too far in decline with senior administrators deserting the Club: Knox was just starting but was gathering a local administration which I joined to become a founding member of this Club. Our request to the Lacrosse Victoria Board has been to advertise the need for at least one experienced Club person to join this Club and maintain the expansion of the sport into outer suburban areas. It needs a vision for growth beyond Club survival.

MELBOURNE UNIVERSITY

2013 saw Melbourne University Lacrosse Club celebrate its 130th birthday, a fantastic achievement. 2013 was a great year for the Club and saw improvements to the club's communications and operations, as well as a number of new initiative and events.

The Melbourne University Lacrosse 2013 Club Committee included 14 individuals. This was an increase on the previous year and is an indication of the willingness of our members to get involved and help out. The committee met regularly throughout the year, and although committee meetings went for longer than we would have liked, they were extremely productive and the discussions robust.

2013 saw the club consolidate its relationship with various stakeholders. Communications with Lacrosse Victoria (LV) was more frequent, and various meetings throughout the year were fantastic in keeping the communication channels open. Thanks in particular to Rod and Kristen in the LV office for their assistance throughout the year. The President/Leadership meetings hosted by LV during the year provided an opportunity for us to meet and discuss issues with other clubs, and explore the possibility of joint projects. Communications with Melbourne University Sport also flowed better, and Kylie's prompt and helpful responses to emails was much appreciated. Melbourne University Lacrosse Club also reconnected successfully with past players, culminating in the re-instatement of the traditional Old Boys match.

In 2013, Lacrosse Victoria moved from a paper-based to online registration. This posed a challenge for Melbourne University Lacrosse, as we need to register senior players with both Lacrosse Victoria and with Melbourne University Sport. However this was resolved by incorporating Melbourne University Sport's requirements into the LV online registration form. It was greatly appreciated that Melbourne University Sport is now happy to accept a spreadsheet summary of membership data, rather than the hardcopy signed forms. Existing senior members received a text message with their sporting pulse login and password, and were able to click a link on their phone to complete the form. For senior players, this proved extremely easy and was a success, with all players being registered prior to the first game.

Although the online registration was a success for seniors, it was problematic in the junior space. With registration being completed online rather than in hardcopy, it was difficult to ensure that parents were completing the online registration, and there is concern that junior players might be completing the online registration process without their parents' knowledge.

The Melbourne University Lacrosse Club committee worked hard to improve club communications. In 2013 a new website was created through Sporting Pulse (although the domain name of <u>www.mulax.org</u> remained the same). This website enabled the committee to more regularly update information on the website, and to advertise upcoming events. Photos were also taken throughout 2013 and posted on the website which also increased the website traffic.

Communications were also improved through utilization of the Sporting Pulse emailing tool. This tool enabled the committee to send out official club communications to all members from a central source. SMS communication was used again in 2013, but a change in SMS providers proved more cost-effective and offered extra features. The other new initiative in club communications was the production of a club newsletter. This newsletter contained articles about club events, interviews with club players as well as team fixtures and ladders. The newsletter was distributed through our past member base and also through the club website and facebook page, which gave us a forum to engage with past players.

Improved communications and an easier registration process led to a smooth start of both the Men's and Women's field Lacrosse season.

Thank you to Millie Caddy who coached our Women's B grade team. Millie's enthusiasm and encouragement helped bring a number of new players into the fold and ensured high attendance rates at training throughout the season and in the lead up to the Intervarsity competition. This rolled into a long meeting in late January where most of the planning for 2013 began.

• We chose to direct LV to accept all the FIL rule changes and run with the one rulebook nationally and domestically and through Don's involvement with the Lacrosse Victoria Technical Committee, he managed to persuade them to accept all the changes.

- The planning for the 2013 Club Referee Accreditation Program began with Chris Brown taking on the role, with oversight and assistance from Don.
- The "Get out to the Clubs" initiative was born as the new link between ALRAV and players and coaches, Alan Frost developed a lot of the policy around this program.
- We agreed to a new policy for meeting conduct. 6.45pm arrival for a 7pm start, with an hour for rules discussion. Introduced an action points list to be reviewed monthly. To streamline the meetings and concentrate on General Business items that were in front of us, we took the path of getting reports submitted and circulated before the meeting so that we did not have to spend a laborious amount of time going through them on the night, merely answer any questions the members had of the reports and move on. Also established a "please remove me" policy from group emails, and that any General Business items that were to go to the vote, had to be circulated prior to the meeting so members could come fully informed, and further we agreed that any contentious issue that was raised on the night could not go to a vote, as members generally preferred some reflection time before making big decisions.
- John and Gail reminded us about the dates for Torquay and Frosty began the preparation for the schedule.
- We finalised our application for a Sporting Uniform Grant to obtain 2 referee shirts for all Clubs.
- Began planning for a match fee increase for 2014.
- Formed a working group to look at the selection policy for the Senior Men's Championships and Denver selection process for 2014.

So those are some of the things we began actioning in January and without going through the entire year, set the tone for a busy year. I feel that at all meetings this year we as a group continued our hard work and followed through on getting the job done. I walked away from each meeting thinking that we had achieved something, and had other projects in the pipeline.

I would like to thank those who hosted meeting and put on some amazing nibbles. Stephen and Di Harrison won the catering award for 2013, followed closely by Chris Brown and Steve and Kerri Green who were tied for second. A special thanks to Frosty, Browny and Greeny who all hosted 2 meeting at their home during the year!

Some other items of note for 2013 include:

- Brendan Pinkerton investigated some options on how to spend/invest some of our funds which resulted in ALRA opening a term deposit account and also contributing to ALRA members' attendance at the inaugural ALA coaching and officiating conference as a professional development exercise. Selected club referees where also invited at ALRA's expense but only a few took it up.
- Another fantastic start to the season in Bendigo where many members stayed overnight thanks to Gail organising accommodation and nibbles.
- Noel McDonald Bursary was awarded to Jake Rooney. While the details of the policy change from "assisting" a player to a developing referee are still being finalised, the executive took the step of awarding the Noel McDonald Bursary as it was seen as an investment in future referee recruitment.
- Every month a lively rule discussion hour was lead by Chris Brown which got all members thinking about some peculiarities in the rulebook as well as a chance for members to table issues they confronted in their recent games.
- Chris Brown and Kelvin Minerds each hosted a Japanese referee during the Senior Nationals and Down Under Cup.

- Chris Brown got nominated for and accepted onto the FIL rules committee, a fantastic outcome for Victoria and Australia to be able to discuss issues with the rulebook directly with a member of the committee.
- Began a dialogue with Lacrosse Victoria to look at recruitment and retention of officials.
- Jason and Don joined LV Technical Committee to advance the previous item and address other issues pertaining to officiating.
- Kelvin and Steve Green went through and updated our constitution to be inline with the new legislation.
- Torquay dates set for 2014, 29th 30th March. Thanks to Gail and John for offering their home.
- As another professional development item, Ian Webb who has been the Strength and Conditioning Coach for several Australian teams will do a presentation on lacrosse officials fitness, training programs recovery etc, to be held at Sports House. A general invite to all Lacrosseurs has been published and we are hoping for quite a good turnout.
- Graham Small organised a venue for our post grand final dinner and a good night was had by those who attended.
- Gail has organised the AGM and liaised with the venue for a smooth night.
- Chris Brown ran a referee training clinic in NSW at the request of ALA.

And so it has been a huge year for ALRAV. Thanks to all who contributed to our success on and off the field. A special thanks to Don and Alan for their support as Vice Presidents, also to Gail who again displayed her professional approach to handling our books, and lastly but definitely not least, a massive thanks to Kelvin. The task of secretary in any organisation is never an easy one and I personally would like to thank Kelvin for all of his tireless work during the year.

Another group who put plenty of time into our development and have continued the upward path of many members is our assessment panel, lead by Neville Balfour as Chief Referee. On behalf of all ALRAV member I would like to thank Neville and his team for their hard work in making us better officials. Alan Chiron, Don Reyment, Mike Slattery, Noel McDonald and Alec Ingles should be recognised for standing on the sidelines during some bleak winter days to improve us. Also a special thanks to John Sedgeway as Deputy Chief Referee who supported Neville all year and stepped up to run things when Neville was away.

In closing I would like to congratulate ALRAV's members who have been selected to attend the World Championships in Denver next year. Alan Chiron will be assessing and Don Lovett, Chris Brown, Steve Green and Brendan Pinkerton will represent Australia as Officials. Good Luck lads and I'm sure you will enjoy the camaraderie of the biggest worlds championships ever held and do Australia proud.





ANNUAL REPORT 2013

The Victorian Lacrosse Foundation is a joint initiative of the previous parent bodies, Victorian Lacrosse Association and the Women's Lacrosse Victoria. The Foundation was established to support the sport of lacrosse in Victoria specifically in the areas of junior development, administration and publicity and promotion of the game.

The Foundation, which commenced in May 1999, is charged with the responsibility of raising, holding and administering a trust fund, which has an initial target of \$1 million. Recent changes to the Trust Deed permit some distributions from the Foundation prior to the Fund reaching the target. Once the target is reached, the fund earnings will be fully available to support projects in the above areas.

During the year, Mr John Nolan has generously agreed to act as Treasurer of the Foundation and he has prepared Annual Accounts for the 2013 year which are currently with the firm of Chartered Accountants Noel Melville & Associates for the annual audit.

The draft accounts show accumulated funds at 30 June 2013 of \$135,241 (30 June 2012 was \$ 128,231). This amount has increased to approximately \$145,000 at the current time.

The Trustees have spent a considerable amount of time and effort over the last 18 months debating the "tax free status" of the Foundation with the Australian Taxation Office. The debate has to date not altered that tax free status, but will result in some changes in the way the Foundation operates going forward.

The VLF Trustees have also been communicating with the Australian Lacrosse Association, and are watching its moves relating to the establishment of a new national Lacrosse Foundation. It is likely that the VLF and the new national Lacrosse Foundation will be able to co-operate for mutual benefit in the future.

The Trustees would like to extend thanks to all those lacrosse devotees who provide ongoing support to the Foundation, and specifically to those who contributed with donations during the 2013 financial year. Particular thanks are due to the representatives of Price Waterhouse Coopers and KPMG who arranged "pro-bono" expert advice in the discussions with the ATO.
